Form for defining consultant services

The services to be provided by the consultants are based on a consultancy agreement, cf. General Conditions for Consulting Services within Building and Engineering (ABR 18), including services, cf. Description of Services for Building and Landscape, 2018 (YBL 2018), published by the Danish Association of Consulting Engineers and the Danish Association of Architectural Firms.

The form is to be used for agreements on split consultancy between the client and the respective technical consultants. The form can also be used for lead consultancy where the service has to be defined in relation to the client and design contractors.

The form serves as an appendix to the respective consultancy agreements, the purpose being to ensure an unambiguous definition and description of the services to be provided by the consultant in connection with design, construction and delivery. The appendix also shows services which are not included in the agreement and for which the client or design contractors are not responsible.

The definition of the services to be provided by the consultants in relation to the description of services appears from the following form and more detailed changes and descriptions next to the individual items.

The left column of the form contains the headlines of the description of services.

The form has five tick columns.

If the 'Client' column has been ticked, it means that the service will be provided by the client or that the service is irrelevant to the agreement. In all cases, the client provides the client's services, cf. the individual items of the description of services and the consultancy agreement. 'Client' means the technical consultant's party to the agreement, also when this party is the lead contractor or lead consultant.

If the 'Architect', 'Landscape architect' and/or 'Engineer' column has been ticked, this means that all services set out in the relevant sections, including sub-sections, of the description of services are included in the services provided by the architect, landscape architect and/or engineer.

If the 'Contractor' column has been ticked, this means that the contractor will provide the service in question – typically in the form of design. However, the form is not an appendix to the construction contract since the scope of the contractor's design must be specified in detail in the contract.

If a column has been ticked with brackets, this means that the party in question only provides information and the like, but is not assumed to provide the service.

The 'Modifications and additions to the description of services' column must be used to specify the service in more detail in the form of expansions, limitations or changes of the normal service; see the description of services.

In the individual sections, especially the sections 'Initial consultancy' and 'Other services', it will not be sufficient to just tick the boxes. It will be necessary to specify in more detail the scope of the service in order to meet the requirement of ABR 18 on clarity of services and terms and conditions.
